Burnley Boys and Girls Club Impact Report

Significant Activities

There has been two extremely successful projects this year that have really stood out and it has given extra confidence to the management and the team in supporting young people, firstly the addition of our satellite club in the Ribble Valley has grown from strength to strength supporting over 250 young people across a six mile radius within a six month period, the second was the HAF summer project that was delivered over the school holidays, supporting 736 young people age between 8-16 daily with breakfast and lunch, fun and activities, this also has led to us making new friends and many more members with the current membership of Burnley now totaling 800 along with Whalley 250.

The Covid pandemic has still had a drain on our services this year, yet all the team have pulled together to meet the demands of the wider community and our members, the collaborative work with the local and county authorities including us becoming a Laterl Flow testing site has really helped to support a smoother delivery of services especially to the more vulnerable, although we have only lost a few weeks to closure the impact of staff shortages has been the most apparent that a new crisis management policy has been introduced to support the running of all the sessions and facilities in an ever facing uncertain world.

The level of partnership work the organization is now engaging in has truly cemented the development of the Charity, working with front line organisations to support young people has helped us to secure the ethos of the organization that has supported Burnley and now the wider area of Lancashire for, almost, 125 years.

FUTURE PLANS

Despite all of the great work from everyone concerned the facilities at Barden are now looking a little dated and tired, sustainability, security and safety for all of the users of the club is paramount and the plan to start redeveloping the site and facilities is now coming to fruition, the building of a Tree Trek Trail in the gardens to the side on Barden Lane will commence in early March next year along with other projects to develop the toilet facilities and sports hall that has all been suggested by the members to make their space that little bit more special for generations to come.
